Welcome,

Race to Resilience (RTR) is a global campaign led by the United Nations Climate Change High-Level Champions. RTR was launched in 2021, COP26, with the objective to mobilize Non-Party-Stakeholders and catalyze a step-change in global ambition for climate resilience, putting people and nature first. The RTR goal is to accelerate action by Non Party Stakeholders, such as subnational governments, the private sector, and civil society to increase the resilience of 4 billion people, those most vulnerable to climate risks.

Non-state actor-led regional, national or global initiatives are invited to register their interest in joining the Race to Resilience by completing the form below.

The function of the Eol is to gather information about candidates that allows us to understand if they meet the RtR inclusion criteria and better understand how their initiative contributes to building resilience and, consequently, how it can contribute to the campaign. By obtaining this data, we can thoroughly evaluate each candidate's profile and their potential to be part of RtR. This information is crucial to ensure that the selected initiatives not only meet the established requirements (see exclusion and decision criteria, see below) but also significantly contribute to the overall goal of the campaign, promoting a more resilient and prepared community to face future challenges.

Every Expression of Interest (Eol) will be reviewed by two members of the RTR [Expert Review Group \(ERG\)](#). The ERG provides technical advice on applications from potential partners. We will contact you as soon as the review process is completed or in case there are any additional questions

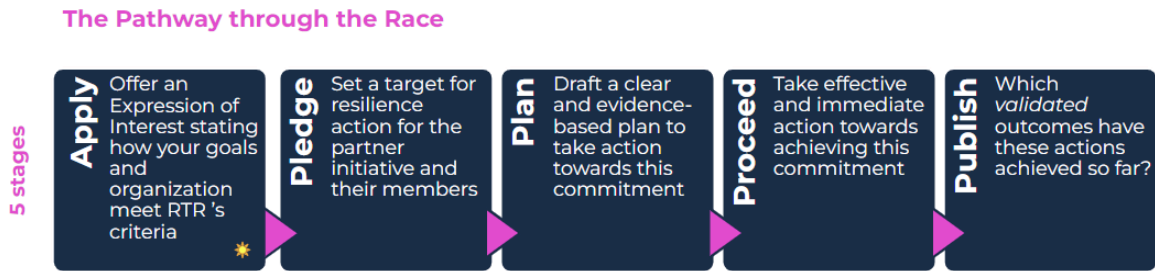

## The Pathway through the Race



**PLEDGE:** commit to setting a target for resilience action for the partner initiative and its members (which impacts or systemic shifts does your initiative pledge to achieve?). The initiative takes between 3 and 6 months after joining the campaign to submit its Pledge after having completed the General Information Survey (when member based, members must have agreed on the Pledge). If the initiative cannot present a numeric target, it has to be willing to present a pledge that details how the initiative will catalyze resilience action in support of people and nature. Initiatives also have to be willing to translate the pledges into numbers of people or hectares of land with increased resilience (using the Metrics Framework we will provide).

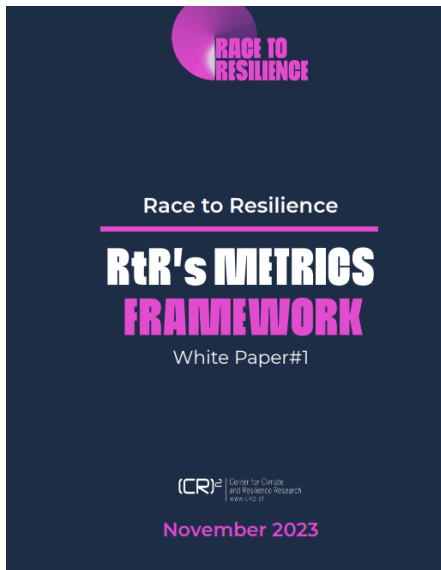
**PLAN:** willing to commit to presenting a clear and evidence-based plan to take action towards its committed pledge(s) in the next 6 months to 1 year after presenting a valid pledge (how, through which actions) do you or your members plan to achieve the pledge?).

**PROCEED:** willing to commit to taking effective and immediate action towards achieving its pledge(s) based on its plan. The initiative commits to report on the proceed stage, on the subsequent year after presenting an accepted plan(s)

**PUBLISH:** willing to commit to providing the results and outcomes that your actions achieved and the evidence to back them (which validated outcomes have these actions achieved so far?) by 2026 or in the subsequent year after presenting the proceed reporting.

### The Race to Resilience Metrics Framework

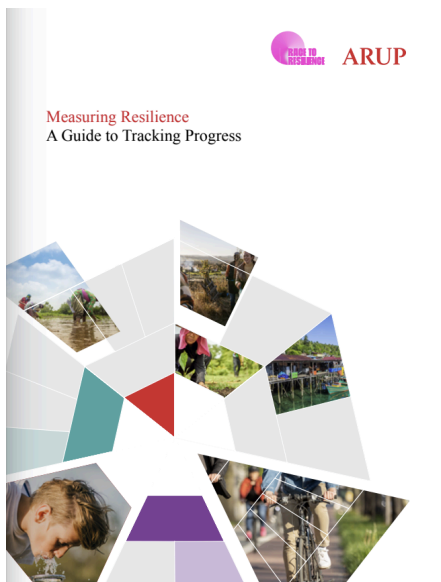


The Race to Resilience Metrics Framework offers an innovative approach to assessing climate resilience initiatives, combining qualitative Depth Metrics with quantitative Magnitude Metrics for a comprehensive impact view. It integrates these metrics into the Monitoring, Evaluation, and Learning cycle, making them dynamic and adaptable over time for the continual improvement of resilience strategies.

This framework also addresses key measurement challenges, enhancing data credibility and robustness, and ensuring trustworthy outcomes for effective, sustainable global resilience efforts.

## Section II: Exclusion criteria.

Exclusion criteria are criteria that an initiative must meet or agree to if it wants to join the campaign. These types of questions are the first filter that determines which initiatives will be evaluated by the ERG.

The initiatives wishing to join the campaign must:

- **Be a Non-Party Stakeholder:** including civil society organizations, the private sector, financial institutions, cities and subnational authorities, local communities and Indigenous peoples initiatives.
- **Share the goals of the RTR:** supporting resilience building efforts that benefit people and/or nature. Actions that are measurable and/or that promote enabling conditions and systemic transformations driving resilience.
- **Commit to report on progress, through the RTR 4Ps Journey:** Pledge, Plan, Proceed and Publish.
- **Agree on being part of the community of practice,** share knowledge and collaborate with other initiatives and partners to drive ambition.

**If your initiative does not meet one or more of these criteria, it will not comply with RTR eligibility requirements.**

*(The initiatives that want to join the campaign must share knowledge and collaborate with other initiatives and partners to drive ambition. If an initiative does not agree on this, it cannot be part of the campaign.)*

**Question.** Does the initiative agree to disclose the information related to its reporting on progress?

*(The initiative must be willing to disclose the information related to the different RTR reporting tools such as General Info Survey, Pledge, Plan, Proceed. All information will be open and accessible in the RTR Data explorer)*

**Responding “No” to one or more of these questions determines that your initiative does not comply with some of the exclusion criteria**, but if you think that your organisation should be considered anyway, an additional page in the survey gives you the opportunity to indicate the reasons that you wish would be taken in consideration to that account. After that, please press the ‘Next’ button, and then in the next page ‘Done’ your information. After we check your information, we will contact you. Please, do not forget to submit your information.

Otherwise, if you wish to review your answer, just press the 'Prev' button.

## Section II: Decision criteria.

**Decision Criteria** is the basis on which the ERG members make their assessment and decide whether to recommend or not an initiative to become a partner.

Initiatives wishing to join the campaign must:

- **Resilience:** Be committed to increasing resilience.
- **Theory of change:** Deliver a step-change in global ambition for climate resilience.
- **Governance:** Have the operational capacity and an active host that can collect and provide RTR with the data required for quantitative and/or qualitative metrics purposes.
- **Inclusivity:** Be committed to delivering inclusive and equitable actions to people from vulnerable and marginalized groups and communities to climate risks.



- **Sustainability:** Do not take actions that harm nature and ecosystems. Impact to positively benefit people's lives and livelihoods)).

*This question refers to the kind of beneficiaries you aim to reach with your actions. RtR accepts 6 types of beneficiaries:*

- *Individuals: it is the main target of the campaign and should be used by all initiatives that work directly with people, households and communities*
- *Companies: it refers to actions that make companies more resilient to climate change risks, and thus, indirectly protect livelihoods or the provision of key services*
- *Cities, regions, countries: it refers to actions that support local administrations in either protecting people from harm or ensuring them key services*
- *Natural systems: actions that protect, conserve or restore ecosystems to make them more resilient to climate change and thus protecting key ecosystem services*

*After your acceptance as RTR partner, you will be asked to provide a pledge statement for each and only the types of beneficiaries you indicate in this question. Please consider that this question refers to the direct beneficiaries (e.g. if you work with city administrations to provide them with better water infrastructure, you are benefitting both cities and individuals but only the former are 'direct' beneficiaries.*
